All cores and re-useable crates must be returned to Fleece Performance within 30 days of receipt. <u>Failure to include this form</u> will result in a partial or full forfeiture of your core charge. <u>The customer is responsible for all return shipping</u> charges unless otherwise indicated separately. Ship all cores to the addresses listed below.

Upon the receipt of a core, Fleece Performance will determine the condition of the core and refund all, part, or none of the core based on the condition as outlined in the CORE ACCEPTANCE POLICY. Any damages or excessive wear may result in a deduction of the core refund. Please allow 14 to 21 days to receive your core refund. If you did not purchase the product directly from Fleece Performance, the credit will be sent to the company from which you purchased the product. If purchased directly from Fleece Performance, a check will be mailed to the billing address.

To receive full core credit the core MUST be re-buildable and of the same make and model year that the product was purchased for. You must also fill out the information below.
