



## **CONTENTS:**

**A** (12) *M8 x 1.25 x 30 Up-Pipe Bolts*

**B** (1) *Thread Lubricant Packet*

**Note:** *PPE L5P OEM Replacement High Flow Up-Pipes available for purchase PN 116122000.*

## **INSTALLATION:**

1. *Insert driver side up-pipe through passenger side and set in place.*
2. *Insert gaskets in place and secure with PPE Up-Pipe Bolts. Hand tight only. Note: Apply a thin layer of supplied lubricant to bolt threads.*
3. *Once all bolts and gaskets are in place torque to 24 lb-ft.*
4. *Install heat shield and tighten bolts to 80 lb-in.*
5. *Install PPE passenger side Up-Pipe, insert gaskets and secure with PPE Up-Pipe Bolts. Hand tight only.*
6. *Torque Up-Pipe bolts to 24 lb-ft.*
7. *Install heat shield and tighten bolts to 80 lb-in.*
8. *Reinstall removed parts back in place.*
9. *Check for exhaust leaks*

***Installation complete.***
